GRANT OF SHARE OPTIONS

This announcement is made pursuant to Rule 17.06A of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”).

The board of directors (the “**Directors**”) of GOME Electrical Appliances Holding Limited (the “**Company**”) hereby announces that the Company has granted share options (the “**Options**”) under its share option scheme adopted on 15 April 2005 to certain directors and employees of the Group (the “**Grantees**”) which, subject to the acceptance of the Options by the Grantees, will enable the Grantees to subscribe for an aggregate of 383,000,000 new shares of HK\$0.025 each (the “**Shares**”) in the share capital of the Company. - (ii) 25% of the Options and any Options that have not been exercised as referred in paragraph (i) above will be exercisable at any time commencing from the second anniversary of the grant of the Options;
- (iii) 25% of the Options and any Options that have not been exercised as referred in paragraphs (i) and (ii) above will be exercisable at any time commencing from the third anniversary of the grant of the Options; and
- (iv) 25% of the Options and any Options that have not been exercised as referred in paragraphs (i) to (iii) above will be exercisable at any time commencing from the fourth anniversary of the grant of the Options.

No Options will be exercisable after the expiry of its term.
