(1) As stated in the announcement of the Issuer dated 15 July 2009, in accordance with the terms and conditions of the Warrant Instrument dated 28 February 2006 in relation to the issue of the warrants entitling the holders thereof to subscribe for up to the aggregate amount of US\$25,000,000 for new shares of the Issuer (the “Warrants”), as a result of the proposed issue of the 2016 CB and the open offer (details of which are set out in the Announcement and prospectus of the Issuer dated 13 July 2009, respectively), the subscription price per share of the Issuer has been adjusted from US\$0.2481 to US\$0.2298 (the “Adjustment”) with effect from 15 July 2009. Following the Adjustment, the maximum number of subscription shares to be issued by the Issuer upon the exercise of the Warrants in full will be 108,790,252 shares of the Issuer.

(2) Completion of the issue of 2016 CB took place on 3 August 2009.

(3) As stated in the announcement of the Company dated 31 July 2009, the Open Offer (as defined in the Announcement) has become unconditional at 4:00 p.m. on Wednesday, 29 July 2009 and 2,296,576,044 shares of the Issuer were issued and allotted on 30 July 2009 pursuant to the Open Offer.
